DELEGATIONS

FireSmart Drone Research presented by Dr. Jeff Boisvert, associate professor at the University of Alberta. Sought to analyzing tree stands to help assess wildfire hazards in and around Seba Beach. They are trying to determine fuel/tree properties from aerial imagery, enhancing our understanding of wildfire potential in the area. This involves conducting aerial surveys. A member of the research team will be piloting a drone over selected tree stands. Weather permitting, this will occur between 9:00-5:00 August 23rd through August 27th. It is not anticipated that these surveys will have any impact on community members, the drones are quiet and unobtrusive.

Mayor MacPhee brought up items related to non-Lakefront landowner pier access. Mayor looked to have a pier installed on the pavilion beach front on the south end of the property. Further brought up allowances on 5th and 6th street north. Noted residences near these accesses are assuming the properties and Council discussed writing letters to these owners about placing a pier on these access points. No motion directing action put forward by Council.
