MAYORS MESSAGE - Doug Thomas

It is difficult to watch the devastation that has recently taken place in Fort McMurray without considering the affects that a major fire would have on our beautiful summer village. As we continue to experience drought conditions throughout the province it is important to realize that the fire ban that continues throughout the province means that no fires are allowed in any outside fire pits. Our Peace Officer and fire officials will be patrolling the village and surrounding area to make sure the ban is upheld. I enjoy sitting around an open fire as much as anybody, but the increased possibility of even a small fire getting out of control is not worth the risk, so please obey the fire ban.

Alberta Municipal Affairs Minister Danielle Larivee provided Council with a report with respect to the inquiry into the affairs of the Council and CAO of the Summer Village. The review was to identify the concerns and issues that led to the petition for an inquiry and to understand if the concerns would be best addressed through an inspection. The review findings revealed that ineffective communication and engagement between some of the summer village residents and Council may have resulted in conflict. It was determined by the Minister that this conflict was not pervasive enough to warrant an inspection.

Sue has completed the financial statements and requisite reporting to the province for another year. I am very pleased to announce another small surplus in our operating statement for the year ended December 31 2015 and a budget for 2016 that has a tax increase of less than a 1%. Unfortunately, this good news is moderated by the fact that the province has increased the school requisition by over 8%. This is a cost born by all rate payers as a percentage of the assessed value of their residence which means that the higher the assessed value of your home the more taxes you will be sending to the provincial government.

Congratulations to the Seniors on celebrating their 40th anniversary. Their presence is an integral part of this community which I hope will continue for many years to come. Please consider attending one of the celebratory events that are scheduled for the weekend of June 10th – 12th. A listing of the planned events is in the Seniors portion of this newsletter.

Public works have been very busy all winter attending to the needs of the Village. In my somewhat biased opinion, I think Seba Beach has one of the best public works departments in the entire province. Given the chance please take a moment to thank them for all they do in keeping our village safe and clean. Our new law enforcement vehicle has been delivered and is fully functional. It was necessary to replace the previous vehicle as it had come to the end of its useful life. Since Council knew that this day would come, we have been financially responsible in creating a capital reserve fund that ensured the funds were available for the acquisition. Jeremy Hampton continues to keep our village safe as our Community Peace Officer. Please remember to obey all speed limits and other traffic bylaws and to be vigilant in advising Jeremy if you see any suspicious activity within the village.

The surveillance system that was installed at the pavilion last year seems to have curtailed the vandalism that was taking place. A special thank you needs to be given to Gary Schultz for getting the system installed and for supervising all of the other renovations at the pavilion.

Don't forget about our annual "clean up Seba" day on Saturday June 4th. Hopefully everyone will pitch in and clean-up any garbage and debris located anywhere throughout the village. If you would like to volunteer to assist Council and staff in this very worthwhile endeavor, please contact Sue at the office. The summer months at Seba are always busy and a little bit hectic so please be considerate of your neighbors and stay safe.

WWMC – Stan Franklin, Chair

The Wabamun Watershed Management Council has been busy over the winter. Here are some of the things we have learned:

- We have been advised that lake levels and ground water levels have been declining in Central Alberta over the past few years. Lower lake levels and warmer temperatures increase the threat to water quality. To obtain some insight into the effect of ground water on lake levels, the WWMC is working with the University of Alberta and stewardship groups from Parkland County lakes to sample lake and well water. The samples will be taken on a weekly basis and submitted to the University for analysis of the isotope contents which will help to determine the source of the water molecules.
- The Highvale Mine site on the south side of the lake represents approximately 1/3 of the area of the total watershed. Runoff from that site is currently captured by TransAlta and transported to its cooling ponds. Treated water is pumped into the lake to compensate for the loss of runoff. When mining ceases and the site is reclaimed, it is vitally important that reclamation will ensure that runoff from this portion of the watershed will not adversely affect the health of the lake and that the volume of runoff will be equivalent to pre-disturbance levels. Parkland County is currently working on a revised Area Structure Plan for this site. More information can be obtained at www.highvaleendlanduseasp.ca.

We are planning projects, including evaluating wetlands around the lake and informing people about invasive species concerns. Everyone is welcome to WWMC meetings, held each third Wednesday at the Alberta Environment and Parks office in Spruce Grove. Go to www.wwmc.ca for more information.

ADMINISTRATION

Regular meetings of Council are generally held on third Thursday of each month. Meeting dates are posted at the administration office or call Sue for confirmation of dates. Everyone is welcome to attend. If you wish to address your Council, please call ahead and Sue will include your item of discussion on the agenda.

Municipal Taxes

Taxes are due on or before June 30th and there will be **no exceptions** made for late taxes. If your payment is received after June 30th a 12% penalty will be imposed. (see your tax notice for additional penalty date information)

The audited financial statement and auditors' certificate have been filed with Municipal Affairs. We are providing the Statement of Operations and Statement of Financial Position in this newsletter. Anyone wishing to review the entire statement please drop by the municipal office.

School Taxes

As you are aware municipalities have no control over school taxes. We are however directed by the Province to carry out the duties of the collecting authority. The 2016 ASFF requisition is in the amount of \$ 354,738.18.

Development Permits are required for most improvement developments affecting your property. **Tony Sonnleitner** is the Development Officer so if you have any questions just give him a call at 780 718-5479 or fax 866 363-3342 or email pcml@telusplanet.net If you wish to obtain a copy of the Land Use By-law, which should answer most of your questions concerning development in the village, contact Sue or Tony for an electronic version of the by-law.

The Inspections Group is the Accredited Agency, which provides compliance monitoring pursuant to the Safety Codes Act of Alberta for building, plumbing, gas and electrical disciplines. Application forms are available at the municipal administration office or may be obtained directly from Inspections Group at 1-866-554-5048 or visit their website www.inspectionsgroup.com **Builder**, please be aware that you are responsible to meet all the Alberta Electrical Communication Utility Code requirements when constructing your new building.

Code 2-014 states: No persons shall construct or place buildings or other objects within the minimum clearances from overhead equipment or lines prescribed by this Code unless it is acceptable to the inspection authority having jurisdiction.

Please follow all safety regulations when working around power lines. All measurements for overhead power lines are to be taken by qualified personnel only or with a range finder from safe limits or approach distances as explained in the code.

SOME REMINDERS

Road Ban – A 75% road ban is in place on all municipal roads. Thank you for your consideration when arranging deliveries, etc.

Alberta 1 Call - 1-800-242-3447. Whether you are involved in a large excavation job or simply installing a fence or planting a tree – don't gamble on the unknown. Remember there are underground gas, electrical and telephone lines. It is a free service so call before you dig. 1st Call suggests you call at least two working days before you plan to dig.

Beach Cultivation – will take place during the months of May or June. Please ensure that any obstacles belonging to your property are not a hindrance to the tractor and keep areas clear. If your property is not accessible for public works to access with the tractor we do have a hand cultivator that you could borrow to cultivate your own beach area. If you would like to arrange for the use of the cultivator or you have piles of weeds to be hauled away give Sue a call at the village office.

Road Allowances – residents are reminded that all road allowances must remain uncluttered and accessible. Please remove all hoists, pier sections and or any other debris from the access roads. Any obstacles remaining on municipal road allowances after June 30th will be hauled away for disposal.

VEHICLE RESTRICTIONS will be in place May through August. No person shall drive or park any vehicle or trailer on any portion of the lakeshore. All road allowance access areas will be closed for the period May 30th until August 26th. Anyone who wants to launch a watercraft is encouraged to use the authorized boat launch at the Village of Wabamun or the Wabamun Provincial Park, where parking for truck / boat trailers is readily available.

Ditches – It is an offence to put ashes, grass, debris, branches etc. in the ditches, lanes or streets. Spring cleanup should be bagged and public works will haul it away for you. When you dump refuse in the ditches you impair drainage adding extra work and expense. Offenders will be charged. Please do not throw rocks / yard waste in the ditches! – You may be removing these items from your property but you are simply creating more work for public works as they have to remove all discarded items from the ditches – Please help keep our ditches clean!!

Solid Waste / Transfer Station information

There are still many properties that do not have adequate garbage stands and containers. Municipal By-law 386 states that garbage containers must be fastened in such a way as to prevent insects and animals from reaching the contents of the containers and that each owner shall provide a suitable stand for his or her garbage containers that will hold them securely and prevent them being tipped over by animals. In the event that it is necessary for public works to clean-up scattered garbage from your property there will be a minimum \$ 50.00 charge for clean-up. All garbage is required to be placed in a garbage can lined with a large garbage bag, not thrown in the cans loosely. Garbage cans full of small grocery sized bags will not be collected. Garbage bags should weigh no more than 35 lb or 16 kg. Cardboard boxes need to be broken down and flattened. Remove styrofoam and place in garbage bags. Ideally multiple boxes should be broken down and tied together. The recycle bin at the Parkland County Transfer Station has small openings so boxes will not fit until flattened down.

Parkland County / Seba Beach Transfer Station

Summer hours for transfer station:

9 a.m. to 5 p.m. Tuesdays and Saturdays only

Compost – Seba Beach and Parkland County have partnered in a new compost venture located adjacent to the Seba Beach Transfer Station. In the interest of the environment please participate in our composting program for grass and leaves. Place your leaves and grass clippings in the clear bags and public works will pick them up and recycle them to the compost pile. If you are able / wish to transport your own compost bags the compost site will be open for drop off Tuesdays and Saturdays for your convenience. If you wish to utilize the existing compost in your gardens and flower beds this season, contact the office and make arrangements for access. Compost must be placed in clear bags only, not black, not green, not orange as they can be mistaken for household garbage. Again, bags should not weigh more than 35 lb or 16 kg.

Garbage Pick-up - is Mondays, sometimes extending into Tuesdays. All garbage must be stored in proper garbage containers with lids, which are fastened to prevent offensive odor and to keep flies and animals out of the containers. All garbage containers must be kept in suitable garbage stands capable of keeping the containers from tipping over. Regulation size garbage cans must be used. If you require a garbage stand to meet village requirements why not call one of our local contractors to build you one!

Dogs are not allowed at large – Please keep pets on leash and respect other people's property. Please clean up after your animals, this is an ongoing problem and we do want an attractive village and clean walking areas.

IRRESPONSIBLE PET OWNERS WILL BE CHARGED.

Fire Permits – are required for the discharge of fireworks.

No open fires with the exception of regulation approved pits or containers. A pit shall be deemed to be approved if it is fully contained on all sides with a mesh screen over top. No opening within the mesh shall exceed 13mm. Permits may be issued by the Administrator or Peace Officer. All fire pits must be constructed on property owner's land.

NO OPEN FIRES ALLOWED ON BEACH OR ACCESS AREAS.

Family Fireworks (low hazard – do it yourself) are only allowed to be discharged with a permit at the following times:

- New Years 8:00 pm December 31st – 1:00 am January 1st
- Canada Day 8:00 pm – 11:59 pm July 1st
- Labour Day 8:00 pm – 11:59 pm on the first Monday of September

High hazard Fireworks also requires a permit. Anyone wishing to discharge high hazard fireworks needs to have a qualified pyrotechnics contractor apply for a permit.

Don't forget the village owns the tennis courts and camp shelter with cook stoves located at the south end of the school grounds. If you wish to play tennis and or have a get-together and / cook out this is an ideal place to go.

The restricted swimming area on the south side of the main pier and the restricted boating areas are registered with the Provincial and Federal Governments and will be marked with regulation buoys. Powerboats must keep outside the markers when towing skiers or cruising and proceed at **DEAD SLOW** when inside the buoys marking restricted boating areas. Public Washrooms located at the pavilion area are for the use of the general public. Please use them with respect.

LAW ENFORCEMENT – Community Peace Officer Jeremy Hampton

Another summer is upon us and it is already looking like it is going to be a hot one! Please remember to check with local, county and the province in regards to fire bans if they are in place.

Fire Bans

Approved fire pits are not exempt during a fire ban and fire permit are rescinded automatically during fire bans, fines and cost associated to the Fire Services having to attend your property may be charged back to you and the property if the fire ban is not followed.

- You may use propane and natural gas fire pits during a fire ban but attention and supervision is required and should not be left unattended.

With the increase in pedestrians and kids out enjoying leisure walks within the community please be considerate and drive with care and attention. Speed limits with the municipality are 30 KPH unless otherwise posted.

Off Highway Vehicles

Off highway vehicles must be insured and registered to be operated within Seba Beach, drivers must carry all proper documentation and vehicle plate attached to the vehicle. While operating an off highway vehicle all traffic laws and restrictions apply. Small children should always be accompanied by an adult and be wearing all the safety equipment. (Golf carts, mini bikes) are not authorized to be on the any roadway or highway in Alberta. All the same laws apply as if you are operating a motor vehicle.

Public Spaces

Please remember that consuming liquor in a public place is prohibited by law and you may be subject to seizure of the alcohol and violation ticket may be issued.
